We've been certified by Great Place to Work, receiving a 97% satisfaction rating among employees and staff. Congratulations to our CEO, David Bennett, for orchestrating such a great team and keeping our organization running smoothly.

On a local level we have made a large impact. We provided grants in the amount of \$193,000 to assist firsttime home buyers. This was through the efforts of our Foundation and donations from REALTOR® members. We also created the Real Estate Apprentice Program (REAP) to mentor and assist in the start of a real estate career for traditionally underserved communities in our area. Through a grant from our Foundation and Affiliate sponsorship we have raised over \$20,000 to deliver this programming.

Speaking of our Affiliates, I'm so proud of our Affiliates and the great work they continue to do. They've raised large sums for the benefit of local charities and continue to provide networking opportunities for our members. They are the goldstandard of Affiliate organizations nationwide.

Your leadership team recently gathered for several days to work on our 3-year strategic plan. This was a time where it was apparent that our local leaders are truly in tune with the market and the needs of our members. A plan was made to face the current and near-future market challenges to help our members
