

**PRO DUES AND FEES - NEW APPLICANTS FOR APRIL 2024**

REALTOR® dues are billed on a calendar-year basis (January through December), with the first partial year prorated according to the month you join.  
 We invoice for the next year's REALTOR® dues October 1.  
 Anyone joining after October 1 must pay the prorated amount for the balance of the current year, plus the renewal dues for the next calendar year.  
 Renewal fees for Stellar Multiple Listing Service are on a separate billing cycle (June 1 of one year through May 31 of the following year).
